

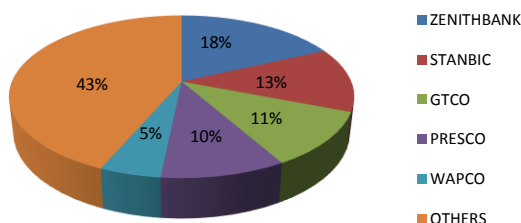
Equities Market Index Rebounds by 0.40% amid Renewed Bargain Hunting Activity; NIBOR Moves in Mixed Directions Across Tenor Bucket...

At the end of Thursday's trade, the domestic bourse closed northwards as the All-share Index rose by 0.40% to close at 37,954.35 points; hence, the year-to-date loss of the NSE ASI fell to -5.75%. Also, the Exchange printed more gainers (20) than losers (14) amid renewed positive sentiment. Specifically, bargain hunting in large cap stocks such as ZENITHBANK, GTCO, BUACEMENT and FBNH increased their respective share prices by prices of tickers such as 1.28%, 1.58%, 214% and 1.41%. Breakdown across sub-sector gauges tracked indicated that four out of five indices closed in green territory; the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.61%, 0.20%, 0.33% and 0.88% respectively. On the flip side, the NSE Insurance Index moderated by 0.30%. Meanwhile, trading activity was weak as total deals and volume of stock traded fell by 3.24% and 19.65% to 3,256 deals and 0.16 billion units respectively. Elsewhere, NIBOR and NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; also, the value of FGN Eurobond fell for most maturities tracked.
