

The domestic bourse closed the week in positive territory as the index rose by 0.83% to close at 38,212.01 points amid renewed bargain hunting activity on blue-chip stocks. Hence, the year-to-date loss of the NSE ASI moderated to 5.11% even as the bulls (23) outnumbered the bears (15). Notably, bellwethers such as SEPLAT, DANGCEM, ZENITHBANK, ACCESS and UBA were the toast of investors today as their respective share prices increased by 1.45%, 4.03%, 0.10%, 0.10% and 0.10%. Of the five indices tracked, three closed in green zone; the NSE Banking, NSE Oil/Gas and the NSE Industrial indices increased by 0.73%, 0.73% and 2.02% respectively. On the flip side, the NSE Insurance and the NSE Consumer Goods indices contracted by 0.68% and 0.01% respectively. Meanwhile, trading activity was weak as total deals and value of stock traded fell by 9.07% and 26.26% to 3,240 deals and N2.0 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid financial liquidity ease; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked.
