

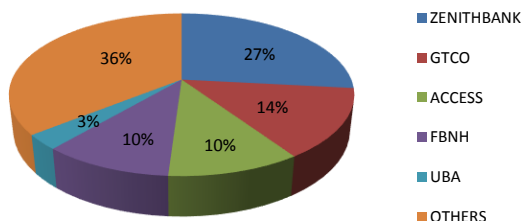
Local Equities Market All-share Index Declines by 0.08% as Gains Halt; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse index moderated by 0.08% to settle at 38,469.87 points amid renewed profit taking activity; hence, the year-to-date loss of the local bourse rose to 4.47%. Sentiment was negative in the market as the number of losers (16) outnumbered that of the gainers (12). Specifically, banking tickers such as GTCO, ACCESS, STANBIC and UBA suffered losses as their respective share prices moderated by 1.84%, 3.17%, 0.73% and 2.60%. Breakdown across sub-sector gauges tracked indicated that three out of five indices closed in green; the NSE Insurance, NSE Oil/Gas and the NSE Industrial indices rose by 0.14%, 1.21% and 0.04% respectively. However, the NSE Banking and the NSE Insurance indices contracted by 0.98% and 0.14% respectively. Meanwhile, trading activity was weak as total deals and volume of stock traded fell by 12.87% and 19.54% to 3,927 deals and 0.23 billion units respectively. Elsewhere, NIBOR rose for most tenor buckets amid financial liquidity strain; also, NITTY increased for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
