

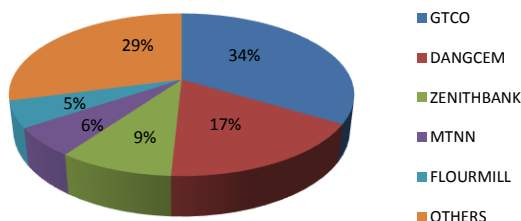
Local Equities Market Index Plunges by 1.24%; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Ease...

The domestic bourse closed the week in negative territory as the index fell by 1.24% to settle at 37,994.19 points amid sustained bearish activity; hence, the year-to-date loss of the local bourse rose to 5.65%. Also, the Exchange recorded more losers (21) than gainers (20) at the close of trading session. Specifically, we saw profit taking activity on heavyweight such as AIRTELAFRI, ZENITHABNK and ACCESS. Hence, their respective share prices plummeted by 9.99%, 0.20% and 0.55%. Sectorial performance was negative as four out of the five indices closed in red; the NSE Banking, the NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices declined by 0.18%, 1.72%, 0.01% and 0.13% respectively. On a positive side, the NSE Industrial index rose by 0.02%. Meanwhile, trading activity was positive as total volume and value of stock traded rose by 1.51% and 4.85% to 0.24 billion units and N2.7 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid financial liquidity ease; also, NITTY decreased for all maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, the value of FGN Eurobond rose for all maturities tracked.
