Local Equities Market Index Advances by 0.01% amid Sustained Bullish Activity; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse index rose marginally by 0.01% to settle at 37,952.65 points amid sustained bargain hunting activity even as the Exchange recorded more gainers (21) than losers (10) at the close of trading session. Hence, the year-to-date loss of the local bourse fell to 5.75%. Specifically, we saw buying interest in Tickers such as PRESCO, ETERNA, CUTIX, GTCO and MANSARD. Hence, their respective share prices increased by 2.94%, 10%, 9.92%, 0.17% and 2.30%. Of the five indices tracked, four closed in positive territory; the NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 1.18%, 0.10%, 0.29% and 0.01% respectively. On the flip side, the NSE Banking index fell by 0.37%. Meanwhile, trading activity was mixed as total deals and volume of stocks traded rose by 17.78% and 73.50% to 3,610 deals and 0.46 billion units respectively; albeit, the value of stocks traded fell by 60.59% to N1.19 billion. Elsewhere, NIBOR rose for all tenor buckets amid financial liquidity strain; however, NITTY fell for all maturities tracked amid buy pressure. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; however, the value of FGN Eurobond moderated for most maturities tracked.
