

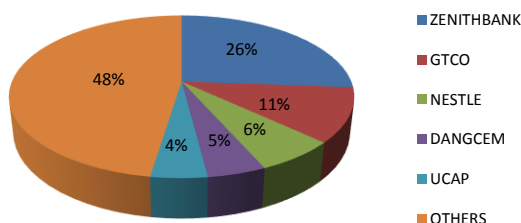
## Bulls Sustain Grip as the NSE All-Share Index Gains 0.21% on Blue-Chip Stock; NITTY Rises for most Maturities amid Bearish Sentiment...

At the close of Friday's trade, the local equities market index rose by 0.21% to settle at 38,667.90 points amid sustained positive sentiment. Hence, the year-to-date loss of the local bourse declined to 3.98%. Also, the Exchange recorded more gainers (30) than losers (11) as share prices of mid and large cap stocks inched higher. Specifically, tickers such as TOTAL, UNILEVER, WAPCO, GTCO and ZENITHBANK increased by 9.96%, 8.75%, 0.46%, 0.34% and 0.81% respectively. Sectorial performance was positive as four out of the five indices tracked closed northwards; the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.51%, 0.40%, 3.98% and 0.04% respectively. On the flip side, the NSE Insurance fell by 0.01%. Meanwhile, trading activity was upbeat as total deals, volume and value of stocks traded rose by 4.18%, 13.36% and 34.04% to 4,135 deals, 0.23 billion units and N1.72 billion respectively. Elsewhere, NIBOR remain unchanged for all tenor buckets; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; however, the value of FGN Eurobond closed flattish for most maturities tracked.
