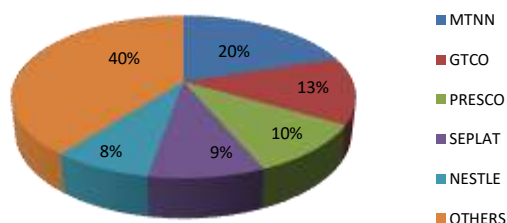
**NSE All-Share Index Rebounds by 0.16% amid Renewed Bullish Activity; NITTY Crashes Finally Moves in the Same Direction with Stop Rate for 364-Day Bill...**

The Nigerian Stock Exchange index rebounded by 0.16% today amid renewed bullish activity. Notably, we saw buying interest in Tickers such as PRESCO, MTN, BUACEMENT and UCAP which resulted in their respective share prices rising by 1.43%, 0.55%, 1.04% and 2.94% to N71.00, N165.00, N68.00 and N7.00 respectively. Hence, the year-to-date loss of the local bourse mellowed to 4.28% despite the Exchange printing lower number of gainers (20) than losers (26). However, performance across sub-sectors failed to mirror the positive benchmark index as the NSE Insurance, NSE Consumer Goods and the NSE Oil & Gas indices fell by 2.94%, 0.08% and 0.15% respectively. On the positive side, only the NSE Banking and the NSE Industrial indexes rose by 0.36% and 0.41% respectively. Meanwhile, trading activity sustained its positive vibe as total volume and value of stocks traded rose 48.92% and 92.53% to 0.39 billion units and N3.82 billion respectively. Elsewhere, NIBOR rose for most maturities tracked amid financial liquidity squeeze while NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions while, the value of FGN Eurobond rose for most maturities. tracked.
