

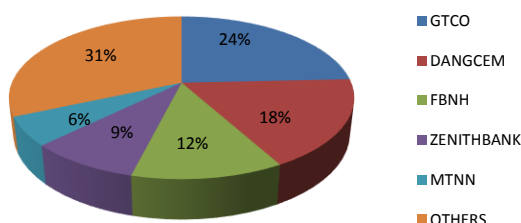
Local Equities Market Rises by 0.02% amid Renewed Bargain Hunting Activity; NIBOR Increases for all Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse All-Share Index rose marginally by 0.02% to settle at 38,810.75 points amid renewed bullish sentiment; albeit the Exchange recorded more losers (12) than gainers (10) at the close of trading session. Hence, the year-to-date loss of the local bourse rose to 3.62%. Notably, buying interest on medium cap stocks such as ARDOVA, GUINNESS, CUTIX, OANDO and ETI increased their respective share prices by 3.33%, 0.63%, 2.73%, 4.13% and 0.93%. However, sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance and NSE Consumer Goods indices declined by 0.05%, 0.39% and 0.01% respectively. On the positive side, the NSE Oil/Gas and the NSE Industrial indices rose by 0.95% and 0.01% respectively. Meanwhile, trading activity was positive as total volume and value of stocks traded increased by 20.03% and 18.07% to 0.16 billion units and N1.66 billion respectively. Elsewhere, NIBOR rose for all maturities tracked amid financial liquidity strain; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
