


Local Equities Market Declines by 0.63% amid Renewed Bearish Activity; NIBOR Moderates for all Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse started the week southwards as the All-Share Index fell by 0.63% to settle at 38,567.26 points amid renewed profit taking activity; albeit the Exchange recorded more gainers (19) than losers (18) at the close of trading session. Hence, the year-to-date loss of the local bourse rose to 4.23%. Specifically, small and large cap stocks such as UPL, CORNEST, ZENITHBANK, DANGCEM and FLOURMILL suffered the most losses following profit taking by investors. Hence, their respective share prices contracted by 9.79%, 3.70%, 0.41%, 3.26% and 2.30%. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance and NSE Industrial indices declined by 0.05%, 0.61% and 1.76% respectively. On the positive side, the NSE Oil/Gas and the NSE Consumer Goods indices rose by 0.03% and 1.01% respectively. Meanwhile, trading activity was positive as total deals and volume of stocks traded increased by 17.23% and 16.20% to 3,830 deals and 0.16 billion units respectively. Elsewhere, NIBOR fell for all maturities tracked amid financial liquidity ease; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
