

At the close of Tuesday's trade, the domestic bourse index advanced by 1.58% which was buoyed by strong buying interest in ICT stocks such as MTNN and AIRTEL. We saw their respective share prices increase by 10% and 2.38%. Consequently, the year-to-date loss of the local bourse fell to 2.71% even as the Exchange recorded more gainers (21) than losers (20) amid investors positive sentiment. However, sectorial performance was weak as four out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices moderated by 0.02%, 0.18%, 0.09% and 0.06% respectively. On the positive side, the NSE Oil/Gas index rose by 0.11%. Meanwhile, trading activity was positive as total deals, volume and value of stocks traded ballooned by 8.64%, 143.41% and 292.59% to 4,161 deals, 0.47 billion units and N3.98 respectively. Elsewhere, NIBOR fell for most maturities tracked amid financial liquidity ease; also, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
