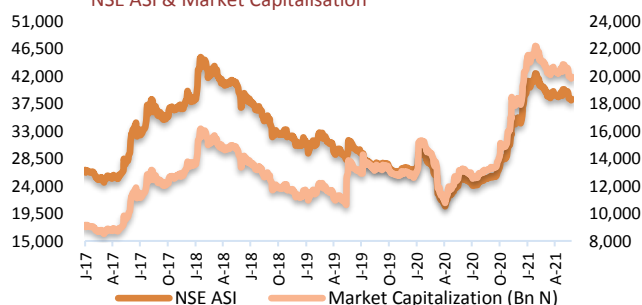


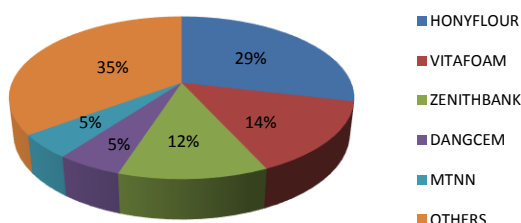
Local Equities Market Index Rises by 0.11% amid Sustained Bullish Activity; NIBOR Moves in Mixed Directions across Tenor Buckets...

The domestic bourse All-share index increased by 0.11% to settle at 39,490.06 points amid sustained bargain hunting activity; albeit the number of losers (20) outweighed that of the gainers (8) at the close of the trading session. Consequently, the year-to-date loss of the local bourse moderated to 1.93%. Specifically, we saw buying interest in large cap stocks such as DANGCEM, GTCO, FLOURMIL and ZENITHBANK. Hence, their respective share prices rose by 0.67%, 1.07%, 3.10%, and 0.41%. However, sectorial performance was weak as four out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices moderated by 0.24%, 1.80%, 0.02% and 0.23% respectively. On the positive side, the NSE Industrial index rose by 0.35%. Meanwhile, trading activity was positive as total deals, volume and value of stocks traded increased by 4.58%, 214.30% and 9.23% to 3,764 deals, 0.57 billion units and N2.28 billion respectively. Elsewhere, NIBOR and NITTY moved in mixed directions across maturities. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked while the value of FGN Eurobond fell for most maturities tracked.
