

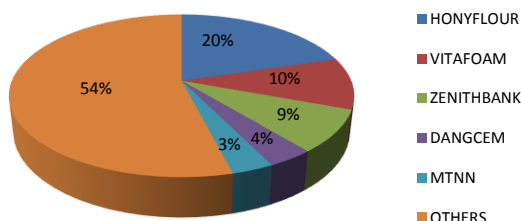
Local Equities Market Index Rises by 0.08% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse closed the week in positive territory as the All-share index advanced by 0.08% to settle at 39,522.34 points amid buying interest in medium and large cap stocks; hence, the year-to-date loss of the local bourse moderated to 1.85%. Notably, sentiment was positive as the Exchange recorded 20 gainers as against 15 losers at the close of trading session. Specifically, tickers such as UNILEVER, FLOURMILL, WAPCO, ZENITHBANK and FBNH closed higher by 7.99%, 1.84%, 2.29%, 0.41% and 0.69% respectively. However, sectorial performance was positive as four out of the five indices tracked closed in green zone; the NSE Banking, Oil/Gas Industrial index fell by 0.54%. Meanwhile, trading activity was weak as total deals and volume of stocks traded decreased by 13.20% and 66.88% to 3,267 deals and 0.18 billion units respectively. Elsewhere, NIBOR and NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked while the value of FGN Eurobond fell for most maturities tracked.
