Nigerian Equities Market Index Falls by 0.04% amid Renewed Bearish Activity; NIBOR Increases for most Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse started the week southwards as the All-share index moderated by 0.04% to settle at 39,05.40 points as investors booked profit on medium and large cap stocks. Consequently, the year-to-date loss of the local bourse rose to 1.90%. Specifically, tickers such as CAP, CADBURY, WAPCO, ZENITHBANK and UBA declined by 3.47%, 0.56%, 1.35%, 0.61% and 0.66% respectively despite the Exchange printing more gainers (25) than losers (15) at the close of trading session. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Oil/Gas and NSE Industrial indices fell by 0.65%, 0.27% and 0.09% respectively. On the positive side, the NSE Insurance and NSE Consumer Goods indices rose by 0.04% and 0.02% respectively. Meanwhile, trading activity was weak as total volume and value of stocks traded contracted by 25.18% and 49.16% to 0.18 billion units and N1.63 respectively. Elsewhere, NIBOR and NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked while the value of FGN Eurobond fell for most maturities tracked.
