

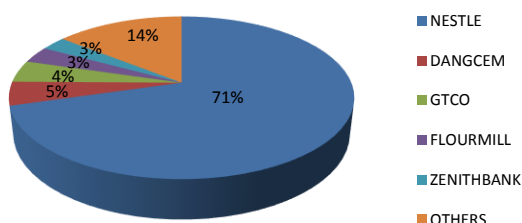
Nigerian Equities Market Index Rises by 0.11% amid Renewed Bullish Activity; NIBOR Increases for most Tenor Buckets amid Financial Liquidity Strain...

At the close of Tuesday's trade, the domestic bourse index advanced by 0.11% to settle at 39,550.36 points even as the Exchange printed equal number (16 apiece) of gainers and losers. Consequently, the year-to-date loss of the local bourse moderated to 1.79%. Specifically, only the NSE Industrial index rose by 1.76% as buying interest in DANGCEM ticker spurred the positive performance recorded. We saw its price inch higher by 3.31%. Also, HONEYWELL and UACN rose by 9.78% and 1.95% respectively. However, the remaining sub-sector indices tracked closed southwards; the NSE Banking, NSE Insurance, NSE Oil/Gas and NSE Industrial indices fell by 0.02%, 1.17%, 4.61% and 0.15% respectively. Meanwhile, trading activity was mixed as total deals and volume of stocks traded contracted by 2.59% and 21.60% to 3,305 deals and 0.11 billion units; however, the value of stocks traded increased by 88.50% to N3.08 billion as N2.17 billion worth of NESTLE exchanged hands today. Elsewhere, NIBOR and NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
