

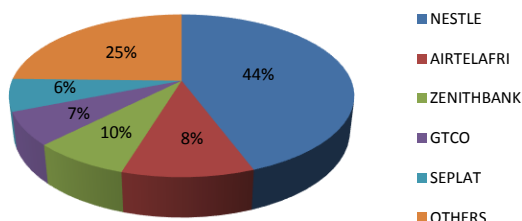
Domestic Equities Market Index Falls by 0.01% amid Renewed Bearish Activity; NIBOR Moderates for all Tenor Buckets amid Financial Liquidity Ease...

At the close of Wednesday's trade, the domestic bourse index declined marginally by 0.01% to settle at 39,545.67 points; albeit the bulls 919) outnumbered the bears (17). Consequently, the year-to-date loss of the local bourse rose to 1.80%. Specifically, tier 1 banking stocks such as GTCO, ACCESS and FBNH moderated by 0.88%, 1.10% and 0.68% respectively as investors booked profit. However, sectorial performance was positive as four out of the five indices tracked closed in green zone; the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices advanced by 0.08%, 0.12%, 0.04% and 0.04% respectively. On the flip side, the NSE Insurance index fell by 0.87%. Meanwhile, trading activity was mixed as total deals and volume of stocks traded rose by 0.06% and 19.23% to 3,307 deals and 0.13 billion units; however, the value of stocks traded declined by 13.29% to N2.6 billion as N1.18 billion worth of NESTLE exchanged hands today. Elsewhere, NIBOR and NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked while the value of FGN Eurobond fell for all maturities tracked.
