Domestic Equities Market Index Rises by 0.32% amid Renewed Bullish Activity; NIBOR Moderates for most Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse index advanced by 0.32% to settle at 39,670.29 points even as the Exchange recorded more gainers (23) than losers (17) at the close of trading session. Consequently, the year-to-date loss of the local bourse moderated to 1.49%. Specifically, buying interest in large cap stocks such as MTNN, WAPCO, ACCESS, FBNH and ZENITHBANK spurred the positive performance witnessed in the Index. Hence, their respective share prices rose by 256%, 3.84%, 1.11%, 0.68% and 0.21%. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Consumer Goods and NSE Oil/Gas indices fell by 0.06%, 1.68% and 0.07% respectively. On the positive side, the NSE Insurance and NSE Industrial indices rose by 0.77% and 0.22%. Meanwhile, trading activity was mixed as total deals and value of stocks traded fell by 1% and 37.17% to 3,274 deals and N1.68 billion; however, the volume of stocks traded rose by 52.82% to N0.20 billion units. Elsewhere, NIBOR and NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for all maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
