Domestic Equities Market Index Falls by 0.47% amid Renewed Profit Taking Activity; NIBOR Moderates for most Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse index closed the week southwards by 0.47% to settle at 39,483.08 points; albeit recording more gainers (21) than losers (15) at the close of Friday's trading session. Consequently, the year-to-date loss of the local bourse rose to 1.95%. Specifically, investors booked profit on small and large cap stocks such as CADBURY, WAPCO, INTBREW and ACCESS; hence, their respective share prices declined by 5.03%, 1.30%, 4% and 1.10%. Of the five sector indices tracked, four closed in the red zone except for the NSE Insurance Index which rose by 0.28%. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices fell by 0.18%, 0.25%, 0.16% and 0.08% respectively. Meanwhile, trading activity was upbeat as total deals, volume and value of stocks traded advanced by 22.54%, 39.01% and 89.48% to 4,012 deals, 0.28 billion units and N3.18 billion respectively. Elsewhere, NIBOR moderated for most tenor buckets tracked amid financial system liquidity ease; however, NITTY moved in mixed directions for most maturities tracked. In the bonds market, the values of FGN bonds fell for most maturities tracked; also, the value of FGN Eurobond fell for all maturities tracked.
