

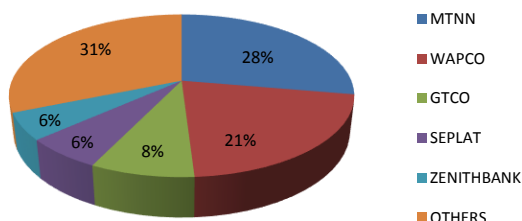
Domestic Stock Exchange Index Gains 2bps amid Sustained Bargain Hunting Activity; NIBOR Rises for all Tenor Bucket amid Financial Liquidity Strain...

The domestic bourse index rose marginally by 0.02% to settle at 39,485.65 points amid sustained bullish activity even as the Exchange recorded 18 gainers as against 10 losers at the close of trading session. Consequently, the year-to-date loss of the local bourse fell to 1.94%. Notably, share prices of tickers such as MTNN, FLOURMILL, UBA and DANGSUGAR increased by 0.29%, 1.22%, 0.67% and 2% respectively. Also, we didn't see much rally in ZENITHBANK share price as the release of its H1 financial result and the interim dividend of 30k came in at almost the close of trade. Sectorial performance was mixed as the NSE Banking and the NSE Oil/Gas indices rose by 0.29% and 0.1% respectively. On the flip side, the NSE Insurance and the NSE Consumer Goods indices fell by 0.65% and 0.25% respectively while the NSE Industrial index closed flat. Meanwhile, trading activity was positive as total volume and value of stocks traded expanded by 24.97% and 3.18% to 0.23 billion units and N1.8 billion respectively. Elsewhere, NIBOR and NITTY rose for most tenor buckets tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities tracked.
