
Domestic Stock Exchange Index Sheds 0.40% amid Renewed Bearish Activity; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Ease...

The domestic bourse index moderated by 0.40% to settle at 39,326.67 points amid renewed sell pressure on blue chip stocks; albeit, the Exchange recorded more gainers (21) than losers (18) at the close of Monday's trading session. Consequently, the year-to-date loss of the local bourse rose to 2.34%. Notably, tickers such as DANGCEM, ZENITHBANK, GTCO, ACCESS and ETERNA moderated by 2.64%, 0.61%, 0.18%, 1.10% and 7.20% respectively as investors booked profit. Of the five indices tracked, three closed in red zone; the NSE Banking, NSE Oil/Gas and the NSE Industrial indices fell by 0.15%, 1.15% and 1.43% respectively. On the positive side, the NSE Insurance and the NSE Consumer Goods indices rose by 0.84% and 1.17% respectively. Meanwhile, trading activity was mixed as total deals and volume of stocks traded rose by 40.70% and 29.27% to 4,715 deals and 0.30 billion units respectively while the total value of stocks traded fell by 17.03% to N1.5 billion. Elsewhere, NIBOR fell for most tenor bucket amid financial system ease; NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities
