

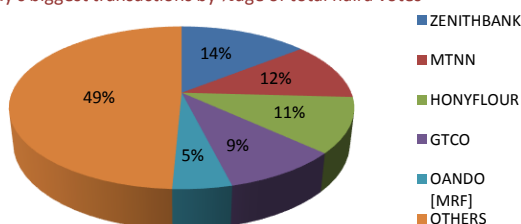
Nigerian Stock Exchange Index Declines by 0.27% amid Sustained Bearish Activity; NIBOR Falls for all Tenor Bucket amid Financial Liquidity Ease...

The domestic bourse index fell by 0.27% to settle at 39,219.61 points amid sustained profit taking activity even as the Exchange recorded more bears (27) than bulls (16) at the close of Tuesday's trading session. Consequently, the year-to-date loss of the local bourse rose to 2.61%. Specifically, profit taking on mid and large cap stocks such as NB, FLOURMILL, OANDO, GTCO and ZENITHBANK lowered their respective share prices by 9.93%, 0.52%, 2.85%, 0.55% and 1.03%. Sectorial performance was weak as four out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.39%, 0.33%, 1.94% and 0.41% respectively. On the other hand, the NSE Industrial index closed flat. Meanwhile, trading activity was positive as total volume and value of stocks traded rose by 82.80% and 6.31% to 0.42 billion units and N1.05 billion respectively. Elsewhere, NIBOR fell for most tenor bucket amid financial system liquidity ease; however, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities tracked.
