

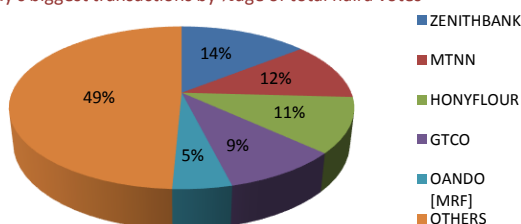
Bearish Trend Sustains Momentum as the NSE ASI Sheds 9bps; NITTY Falls for most Maturities amid Demand Pressure...

At the close of Wednesday's trading session, the domestic bourse index moderated by 0.09% to settle at 39,184.18 points amid sustained bearish activity even as the Exchange printed more bears (17) than bulls (9). Consequently, the year-to-date loss of the local bourse worsened to 2.69%. Specifically, tickers such as NB, UACN, FBNH, ACCESS and OANDO fell by 2.93%, 1.82%, 0.67%, 1.10% and 0.45% respectively as investors booked profit. Sectorial performance remained weak as four out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.23%, 0.20%, 0.62% and 0.08% respectively. On the other hand, the NSE Industrial index closed flat. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 24.25%, 60.23% and 27.60% to 3,449 deals, 0.16 billion units and N1.42 billion respectively. Elsewhere, NIBOR moved in mixed directions across tenor bucket; however, NITTY fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of FGN bonds increased for most maturities tracked. Elsewhere, the value of FGN Eurobond rose for all maturities tracked.
