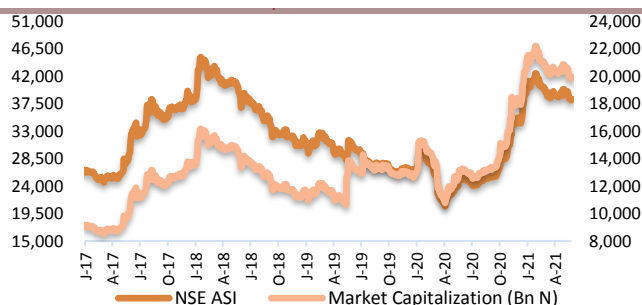
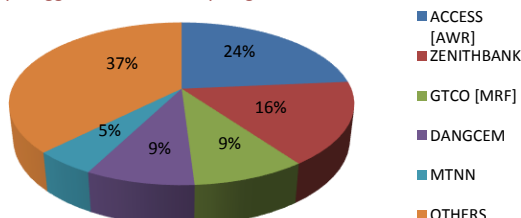


Nigerian Exchange Rebounds by 0.17% amid Renewed Bullish Activity; NIBOR Falls for all Tenor Buckets amid Ease in Financial System Liquidity...

At the close of Thursday's trading session, the domestic bourse index advanced by 0.17% to settle at 39,252.19 points amid renewed positive sentiment; hence, the year-to-date loss of the local bourse declined to 2.52%. However, the Exchange recording more losers (18) than gainers (16). Notably, ACCESS rose by 2.78% as the company released its H1 2021 financial results and declared an interim dividend of 30k. The positive banking results spurred buying interest in other tier 1 banking tickers such as GTCO, ZENITHBANK, FBNH and UBA; hence their respective share prices rose by 0.18%, 0.21%, 0.67% and 1.3%. Of the five indices tracked, three closed in green zone; the NSE Banking, NSE Insurance and the NSE Industrial indices rose by 0.19%, 1.07% and 0.44% respectively. On the other hand, the NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.06% and 1.22% respectively. Meanwhile, trading activity was upbeat as total deals, volume and value of stocks traded increased by 14.67%, 54.84% and 40.34% to 3,955 deals, 0.26 billion units and N1.99 billion respectively. Elsewhere, NIBOR and NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. Elsewhere, the value of FGN Eurobond rose for most maturities tracked.
