

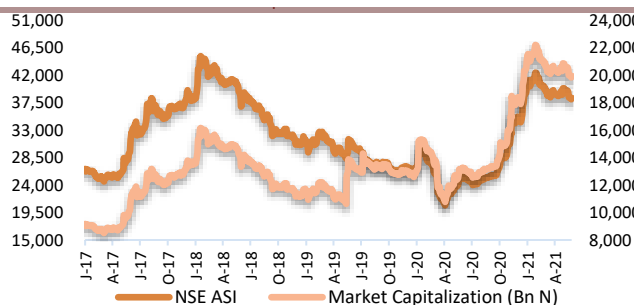

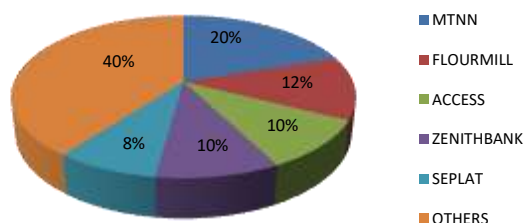

Nigerian Exchange Index Revs by 0.02% amid Sustained Bullish Activity; NIBOR, NITTY Fall for Most Tenor Buckets on Liquidity Ease...

At the close of today's trading session, the local bourse index revved by 0.02% to settle at 39,261.01 points amid sustained positive sentiment. Hence, the year-to-date loss of the domestic bourse fell to 2.57%. However, the Exchange recorded more losers (13) than gainers (16). We saw buying interest in FLOURMILL, WAPCO, GTCO, AFRIPRUD and NEIMETH, leading to a rise in their respective share prices by 3.99%, 1.82%, 1.27%, 2.46% and 7.57%. However, performance across the sub-sector gauges did not mirror that of the benchmark index as three out of the five sub-indices tracked closed in red; the NSE Banking, NSE Insurance and the NSE Oil/Gas indices moderated by 0.01%, 0.57% and 0.12% respectively. On the other hand, the NSE Industrial and the NSE Consumer Goods indices increased by 0.11% and 0.13% respectively. Meanwhile, trading activity was quiet as total deals, volume and value of stocks traded decreased by 20.15%, 31.22% and 13.76% to 3,156 deals, 0.18 billion units and N1.72 billion respectively. Elsewhere, NIBOR and NITTY further moved southwards for most maturities tracked amid sustained financial liquidity ease. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked; however, the value of FGN Eurobond decreased for most maturities tracked.
