

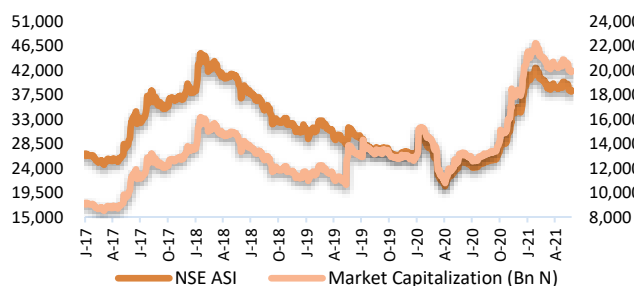

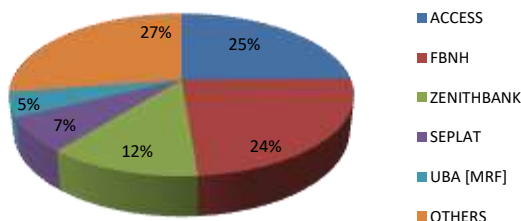

Local Bourse Index Stays Flat Despite Increased Activities; NITTY Moves in Mixed Directions Showing Skepticism amongst Traders ahead of Auction...

The domestic stock market index was relatively flattish at 39,251.29 points despite the increased level of activity witnessed in the market today. The number of losers (21) which outweighed that of the gainers (15) speaks to the marginal bearish turn on the Exchange. While we saw buying interest in JBERGER, UCAP, AFRIPOD and HONYFLOUR, it was more of a sell-off on UACN, ETI GTCO and TRANSCOHOT. Hence, the year-to-date loss of the domestic bourse remained unchanged at 2.53%. Performance across sub-sector gauges was mixed as the NSE Banking and the NSE Insurance indices moderated by 0.31% and 0.90% respectively. While the NSE Consumer Goods and the NSE Oil/Gas indices rose by 0.52% and 1.00% respectively, the NSE Industrial index closed flat. Meanwhile, trading activity was healthier today as total deals, volume and value of stocks traded rocketed by 6.32%, 68.73% and 107.55% to 4,241 deals, 0.36 billion units and N2.87 billion respectively. Elsewhere, NIBOR closed higher for most maturities tracked amid liquidity strain. However, NITTY moved in different directions for most maturities tracked amid skepticism amongst traders ahead of tomorrow's auction. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond decreased for most maturities tracked amid sustained bearish momentum.
