

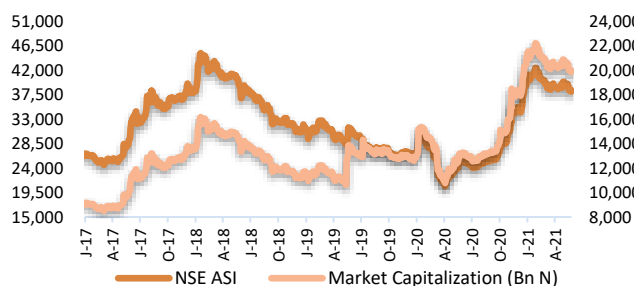

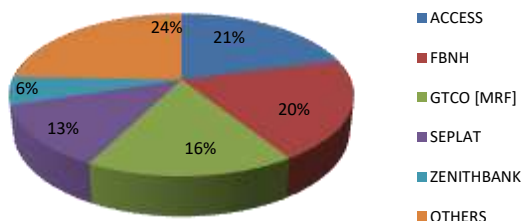

Bearish Sentiment Dominates Equities Market as ASI Falls Further by 0.12%; NITTY Rises for All Maturities as Traders Anticipate Higher Rate...

The local equities market index fell by 0.12% to 39,204.52 points amid sustained profit taking activity; albeit, the number of losers (15) equaled that of the gainers (15). Hence, the year-to-date loss of the local bourse increased to 2.64%. Bearish sentiment was more felt in the banking sector as share prices of GTCO, STANBIC and ZENITHBANK moderated by 1.99%, 0.51% and 0.83% respectively. Performance across sub-sector gauges was also bearish as the NSE Banking, NSE Insurance, the NSE Consumer Goods indices moderated by 0.32%, 1.01% and 0.08% respectively. While the NSE Oil/Gas index rose by 0.55%, the NSE Industrial index closed flat. Meanwhile, trading activity mixed as total deals and volume of stocks traded decreased by 3.44% and 0.53% to 4,095 deals and 0.35 billion units. However, value of stock traded rose by 11.52% to N3.20 billion respectively. Elsewhere, NIBOR closed lower for most maturities tracked amid liquidity ease. However, NITTY rises for all maturities tracked as traders anticipate higher rate in today's primary market auction. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond decreased for most maturities tracked amid sustained bearish momentum.
