

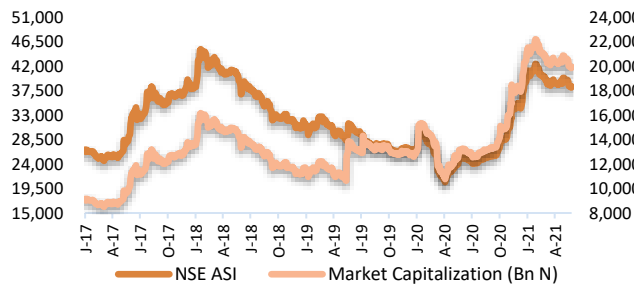

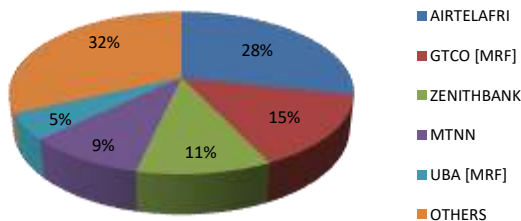

NSE All-Share Index Plummets by 0.71% amid Sustained Profit Taking Activity; NIBOR, NITTY Climbs Northward as CBN Reverses Rate Upward...

The local stock market index plunged by 0.71% to 38,921.78 points amid sustained profit taking activity even as investors moved their funds to the fixed income market amid rising interest rates. Hence, the year-to-date loss of the local bourse ballooned to 3.35% even as the total number of losers (20) outweighed that of the gainers (20). Sectoral performance was mixed – the NSE Insurance and the NSE Consumer Goods indexes rose by 0.10% and 0.02%. On the flip side, the NSE Banking and the NSE Oil/Gas indices fell by 0.84% and 0.16% respectively; while the NSE Industrial remain unchanged. Meanwhile, we saw total deals, volume and value of stocks traded nosedived by 1.59%, 55.91% and 32.25% to 3,467 deals, 0.15 billion units and N2.27 billion respectively as investors exchanged shares of AIRTELAFRI, UBA and ACCESS at lower prices. Elsewhere, NIBOR rose for all maturities tracked as banks with liquidity demanded for higher returns. Also, NITTY rose for most maturities tracked as traders anticipate further hike in rate as they go for auction in the coming week. In the OTC bonds market, the values of FGN bonds moved in mixed directions- we expect yields increase going forward given the demand pressure on the greenback. However, the value of FGN Eurobond increased for most maturities tracked amid demand pressure.
