## Cowry Daily Market Insight 14 September 2021


NSE All-Share Index Up 1bps amid Bargain Hunting on Few Bellwether Stocks; NITTY Pumps amid Expectation of Higher Stop Rate ahead of Tomorrow's Auction ... The local stock market All-Share Index rose marginally by 0.01% to 38,920.50 points amid renewed bargain hunting activity, especially on bellwether stocks such as WAPCO, FLORMILL and ZENITHBANK. Consequently, the year-to-date loss of the local bourse inched downwards to 3.35% despite the total rising number of losers to (21) which outweighed that of the gainers (14). Performance amongst the sector gauges showed that general market positive sentiment is still weak as three out of the five sub gauges closed negative – the NSE Insurance, NSE Oil/Gas and the NSE Consumer Goods indexes declined by 0.85%, 0.08% and 0.39% respectively. Positively, the NSE Banking and the NSE Industrial indices rose by 0.09% and 0.13% respectively. Meanwhile, market activity was mixed as the value of stocks traded moderated by 25.63% to N1.88 billion. However, volume of stock traded increased by 13.61% to 0.23 billion units. Elsewhere, NIBOR rose for most maturities tracked amid financial liquidity squeeze. Also, NITTY rose for most maturities tracked amid anticipation of further increase in yield. In the OTC bonds market, the values of FGN bonds fell for most maturities amid bearish activity. However, the value of FGN Eurobond increased for most maturities tracked as demand for dollar denominated asset increase.
