

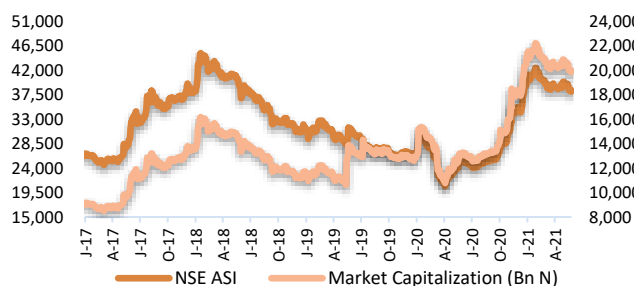

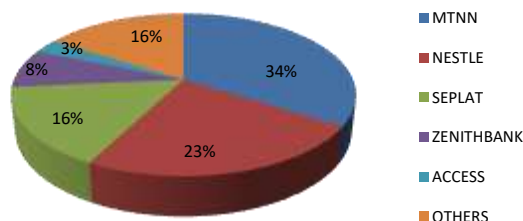

NSE All-Share Index Revs by 12bps amid Sustained Bargain Hunting; NITTY Moves in Mixed Directions as Investors await T-Bills Auction Result...

The local stock market All-Share Index rose further by 0.12% to 38,968.34 points amid sustained bargain hunting activity on bellwether stocks such as MTNN, OANDO and GTCO. Consequently, the year-to-date loss of the local bourse lowered to 3.23% even as the total number of losers reduced to (18 from 21), albeit it still outweighed that of the gainers which was sticky at (14). Performance amongst the sector gauges was weak as three out of the five sub gauges closed negative – the NSE Banking, NSE Insurance and the NSE Oil/Gas declined by 0.39%, 1.15% and 2.00% respectively. The NSE Consumer Goods indexes and the NSE Industrial indices closed flat. Meanwhile, market activity printed huge transaction value as investors put more money in MTNN and Nestle shares. Hence, the value of stocks traded surged by 58.27% to N2.97 billion. However, volume of stock traded reduced by 38.11% to 0.14 billion units. Elsewhere, NIBOR moved in mixed directions across maturities tracked. Also, NITTY moved in mixed directions across maturities tracked – the rise at the longer end of the curve speaks to market expectation of increase in 364-day stop rate. In the OTC bonds market, the values of FGN bonds were majorly flattish. However, the value of FGN Eurobond rose for most maturities tracked.
