



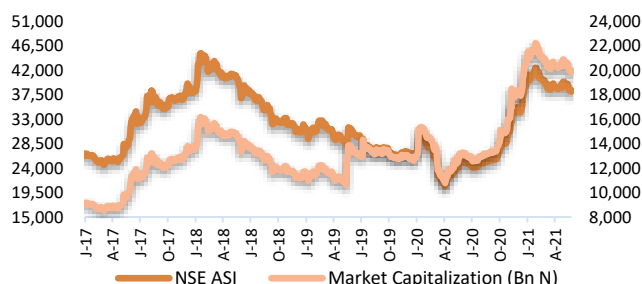

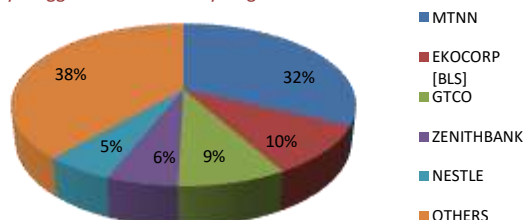
NSE All-Share Index Falls by 0.10% amid Renewed Profit Taking Activity; NIBOR Moderates for All Tenor Buckets amid Financial Liquidity Ease...

The Nigerian equities market All-Share Index moderated by 0.10% to 38,906.42 points amid renewed profit taking activity despite the Exchange recording equal number of gainers and losers (19). Hence, the year-to-date loss of the local bourse increased to 3.39% as GTCO, PZ and ZENITHBAK shares shed value today. Performance for most sub-sectors was negative as three out of the five sub-indices closed southward. Specifically, the NSE Insurance, NSE Consumer Goods and the NSE Banking indexes declined by 0.27%, 0.70% and 0.16% respectively. However, the NSE Oil/Gas and the NSE Industrial indices increased by 0.08% and 0.13% respectively. Meanwhile, market transactions came in positive as investors bought the dip. Hence, volume and value of stock traded rose by 23.12% and 20.92% to 0.19 billion units and N2.35 billion respectively. Elsewhere, NIBOR fell for all maturities tracked amid renewed financial system liquidity boost. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. However, the value of FGN Eurobond further moderated for all maturities tracked amid sustained sell-off.
