Local Equities Market Drags amid Sell-off on Tier 1 Banks; Activity in the OTC Bonds Market Slow as Traders Await Bond Auction Result...


The local bourse All-Share Index moderated further by 0.08% to 38,873.85 points amid sustained profit taking activity despite the Exchange recording a higher number of gainers (16) than losers (13). Hence, the year-to-date loss of the local bourse expanded to 3.47% as ZENITHBANK, GTCO and ACCESS share prices suffered a setback. Hence, the NSE Banking index declined by 0.97%. However, we saw investors' buying interests manifest in other sub-sector gauges as their respective indices closed positive. Notably, the NSE Insurance, NSE Oil/Gas and the NSE Industrial indexes rose by 0.07%, 0.06% and 0.08% respectively. Meanwhile, market transactions came in weak amid investor's sell-off on tier 1 banks. Hence, volume and value of stock traded fell by 3.41% and 0.42% to 0.18 billion units and N2.34 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked amid renewed financial system liquidity strain. However, NITTY moved upward for all maturities tracked amid renewed bearish trend. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked as traders await bond auction result today. However, the value of FGN Eurobond increased for most maturities tracked amid renewed bullish sentiment.
