



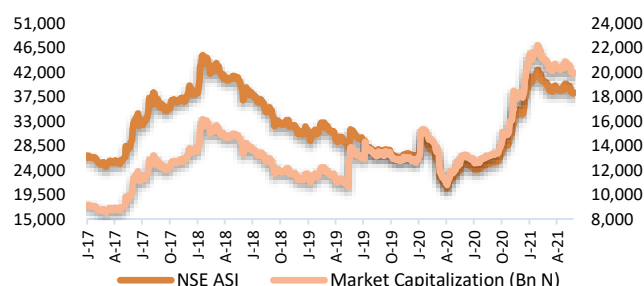

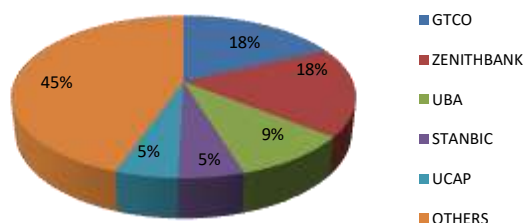
Domestic Stock Market Falls by 0.05% amid Sell-Off on GTCO, ACCESS and UCAP Shares; DMO Stimulates Interest in Fixed Income, Raises Stop Rates on FGN Bonds...

The local bourse All-Share Index moderated further by 0.05% to 38,852.69 points amid sustained bearish sentiment, especially on banking stocks. Similarly, the Exchange printed higher number of losers (17) than gainers (13). Hence, the year-to-date loss of the local bourse expanded to 3.52%. Obviously, the NSE Banking index declined further by 0.83%. However, the insurance, oil & gas and industrial stocks continued to enjoy investors' patronage, thus lifting the NSE Insurance, NSE Oil/Gas and the NSE Industrial indexes higher by 1.21%, 0.50% and 0.01% respectively. Meanwhile, market transactions remained weak amid sustained sell-off on banking stocks, hence moderating volume and value of stock traded by 15.54% and 35.55% to 0.16 billion units and N1.51 billion respectively. Elsewhere, NIBOR rose further for most tenor buckets tracked amid sustained financial system liquidity strain. Also, NITTY moved upward for all maturities tracked amid sustained bearish trend. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked even as DMO auctioned FGN Bonds at higher stop rates today. However, the value of FGN Eurobond declined for all maturities tracked amid renewed bearish sentiment.
