





NSE ASI Falls Marginally by 0.01% as the Bulls and the Bears Fight for Dominance; NIBOR Rises for Most Maturities amid Financial Liquidity...


The domestic stock exchange All-Share Index (ASI) declined further by 0.01% to 38,858.99 points amid stiff competition between the bulls and the bears. This struggle for dominance was reflected in the number of gainers (14) and losers (15) registered on the Exchange today. Hence, as the bears maintained its dominance, the year-to-date loss of the local bourse rose further to 3.51%. Notably, we saw huge percentage drop in the share price of AFRIPUD and MANSARD. Others that recorded decline in share prices include, ZENITHBANK and FCMB. Hence, the NSE Insurance and the NSE Banking indexes fell by 3.39% and 0.30% respectively. Meanwhile, market transactions came in very strong given the huge value of HONYFLOUR shares (N1.53 billion) that exchange hands today, hence lifting the volume and value of stock traded by 277.40% and 77.78% to 0.53 billion units and N3.04 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked. However, NITTY moved southwards for most maturities tracked amid sustained bullish trend. In the OTC bonds market, the values of FGN bonds closed lower for all maturities tracked. Also, the value of FGN Eurobond moderated for most maturities tracked on bearish sentiment.
