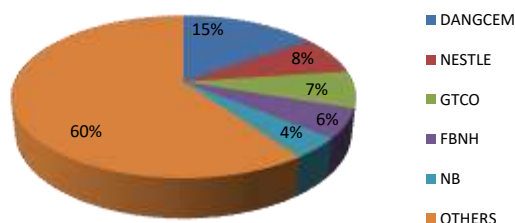
Nigerian Equities Market Revs by 1.59% on DANGCEM Shares; NIBOR Rises Further for Most Maturities amid Tight Financial System Liquidity...

The domestic equities market All-Share Index (ASI) revved by 1.59% to stay above 40,000 points level as investors committed more funds to buying DANGCEM shares today. Other companies such as PRESCO, OKOMUOIL, NB and MAYBAKER also enjoyed investors' patronage, hence making the number of gainers (20) stand above that of the losers (14) at the close of trading session. Hence, the year-to-date loss of the local bourse melted to 0.12%. Given the appreciable capital gain in DANGCEM shares, we saw the industrial index rise by 4.08% to close at 2,089.38 points. Other sub-sector witnessed bearish turn as the NSE Consumer Goods, NSE Banking, NSE Oil/Gas and the NSE Insurance indexes fell by 0.13%, 0.30%, 0.12% and 0.03% respectively. Meanwhile, market transactions came in strong given the huge value of DANGCEM shares (N1.13 billion) that exchange hands today, hence lifting the volume and value of stock traded by 120.65% and 31.57% to 1.05 billion and N7.42 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked on sustained financial system liquidity strain. However, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. However, the value of FGN Eurobond appreciated for most maturities tracked on renewed bullish trend.
