#### Nigerian Equities Market Sustains Bullish Trend as ASI Rises by 0.05%; NIBOR Moves Northwards for All Tenor Buckets on Bearish Activity...

The local equities market All-Share Index (ASI) rose by 0.05% to comfortably climb to 40,243.05 points level as investors continued to lock in their monies in quoted companies. Shares of companies such as ETERNA, UCAP, MANSARD, PHARMDECO and LIVESTOCK enjoyed investors' patronage the most even as the number of gainers (23) outweighed that of the losers (14) today. Hence, the year-to-date loss of the local bourse mellowed to 0.07% to move towards the positive borderline. Sub-sector gauges were largely bullish as the NSE Consumer Goods, NSE Banking and the NSE Insurance indexes increased by 0.01%, 1.53% and 0.05% respectively. On the flip side, the NSE Oil/Gas and the NSE Industrial index moderated by 0.38% and 0.02% respectively. Meanwhile, market activity was weak today as the volume and value of stock traded decreased by 80.67% and 74.88% to 0.20 billion and N1.82 billion respectively. However, number of deals increased by 8.37% to 4,066 deals. Elsewhere, NIBOR moderated for most tenor buckets tracked on renewed financial system liquidity boost. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. However, the value of FGN Eurobond depreciated for most maturities tracked on renewed bearish activity.
