


**Local Bourse Index Year-to-Date Performance Moves into Positive Territory Gains 1.18% Today; NIBOR Rises for Most Tenor Buckets on Financial Liquidity Strain...**

The local equities market All-Share Index (ASI) ballooned by 1.18%, rocketing to 40,716.66 points level as investors remained bullish on local stock. Notably, bellwether shares enjoyed investors' patronage today, especially shares of AIRTELAFRI, JBERGER, FBNH, GTCO and ZENITHBANK. Amid bargain hunting on more companies today, the number of gainers increased to (32) outweighing that of the losers (18). Hence, the year-to-date performance of the local bourse crossed into positive territory of 1.11%. Given the gains recorded by most banks, the NSE Banking index rose by 2.50%. Also, the NSE Oil/Gas index rose by 0.80%. However, we saw the NSE Consumer Goods, the NSE Insurance and the NSE Industrial indices mellow by 0.44%, 1.15% and 0.01% respectively. Meanwhile, market activity was very strong today as the volume and value of stock traded increased by 113.98% and 67.63% to 0.43 billion and N3.13 billion respectively. Also, number of deals increased by 7.65% to 4,377 deals. Elsewhere, NIBOR rose for most tenor buckets tracked on renewed financial system liquidity strain. Also, NITTY moved northwards for most maturities tracked amid bearish sentiment. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. However, the value of FGN Eurobond depreciated for all maturities tracked on sustained bearish activity.
