

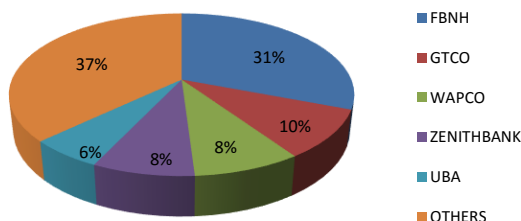
Local Bourse Extends Bullish Streak as Benchmark Index Rises Further by 0.12% on FBNH Shares; NIBOR Tumbles for All Tenor Buckets on Financial Liquidity Boost...

The domestic stock market All-Share Index (ASI) increased by 0.12% to 40,765.20 points level amid sustained investors' preference for banking shares. Today, shares of FBNH, NNFM, UACN, AFRIPUD and WAPCO were the top five gainers. Hence, the year-to-date performance of the local bourse rose to 1.23%. Despite the northward movement in the ASI, the number of losers (20) still outweighed that of the gainers (19) – suggestive of more wins in bellwether stocks. Amid sustained investors' interest in banking shares, the NSE Banking index rose further by 0.06%. Also, the NSE Industrial index rose marginally by 0.05%. However, we saw the NSE Consumer Goods, the NSE Insurance and the NSE Oil/Gas indices dipped by 0.67%, 0.15% and 0.04% respectively. Meanwhile, market activity was mixed even as we saw strong interest in FBNH shares (over N1 billion worth exchanged hands today). Thus, the value of stock traded increased by 11.33% to N3.48 billion. However, volume of stock traded fell by 7.47% to 0.40 billion. Elsewhere, NIBOR fell for most tenor buckets tracked on renewed financial system liquidity boost. However, NITTY rose for most maturities tracked amid bearish sentiments. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked. However, the value of FGN Eurobond depreciated for all maturities tracked on sustained bearish activity.
