

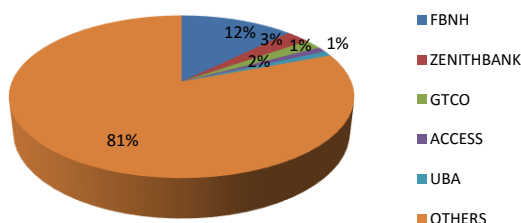
NSE ASI Up 16bps amid Rising Interests in Banking Stocks; NIBOR Falls for Most Tenor Buckets on Sustained Financial Liquidity Boost...

The local equities market All-Share Index (ASI) increased further by 0.16% to 40,829.15 points amid sustained investors' preference for banking shares. Today, shares of FBNH, ETI, PRESCO, OKOMUOIL and WAPCO topped the gainers' table. Hence, the year-to-date performance of the local bourse pumped to 1.39% even as we saw the number of gainers (24) outweigh that of the losers (20). Amid sustained investors' interest in banking shares, especially in FBNH shares, the NSE Banking index rose further by 0.70%. Also, the NSE Industrial and the NSE Consumer Goods indexes rose marginally by 0.08% and 0.06% respectively. However, the NSE Insurance index fell by 1.24% while the NSE Oil/Gas index remained flat. Meanwhile, market activity came in strong given the N1.33 million worth of FBNH shares that exchanged hands today. Thus, the volume and value of stock traded increased by 102.74% and 203.95% to 0.81 billion units and N10.58 billion respectively. Elsewhere, NIBOR fell for most tenor buckets tracked on sustained financial system liquidity boost. However, NITTY rose for most maturities tracked amid sustained sell-offs. In the OTC bonds market, the values of FGN bonds moved southwards for all maturities tracked amid renewed bearish sentiment. However, the value of FGN Eurobond appreciated for all maturities tracked on renewed bullish sentiment.
