Local Bourse Index Rises by 10bps as Banking Shares Remain the Toast of Investors; NIBOR Falls for Most Tenor Buckets on Sustained Financial Liquidity Boost...

The domestic equities market All-Share Index (ASI) increased by 0.10% to 40,868.36 points as banking shares remained the toast of investors today. Shares of ZENITHBANK, ETI and GTCO were amongst the top gainers list as the number of gainers (23) outweighed that of the losers (17). Hence, the year-to-date performance of the local bourse rose to 1.48% given the six consecutive days of bargain hunting activity. Amid sustained investors' interest in banking shares, the NSE Banking index rose strongly by 1.20%. Also, the NSE Insurance index rose by 0.05%. However, the NSE Industrial was flattish while the NSE Consumer Goods and the NSE Oil/Gas indexes fell by 0.03% and 0.12% respectively. Meanwhile, market activity was weak despite the N1.49 million worth of FBNH shares that exchanged hands today. Thus, the volume and value of stock traded plummeted by 59.29% and 72.40% to 0.33 billion units and N2.92 billion respectively. In the fixed income market, NIBOR fell for most tenor buckets tracked on sustained financial system liquidity boost. Also, NITTY fell for most maturities tracked amid renewed bullish momentum. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked. However, the value of FGN Eurobond decreased for all maturities tracked on renewed bearish sentiment.
