

The domestic equities market witnessed a pullback today, following six days of bargain hunting activities, as the All-Share Index (ASI) moderated by 0.38% to 40,714.00 points due to declines in share prices of NB, GUINNESS, BUACEMENT, GTCO and STANBIC. Hence, the year-to-date gain of the local bourse mellowed to 1.10% However, the Exchange still recorded equal number of gainers and losers (17) as investors began to cherry pick shares of better performing companies. Banking stocks remained the toast of investors given the decent dividend yield they offer – the NSE Banking index rose by 0.75%. Also, the NSE Insurance index rose by 0.44% while the NSE Oil/Gas index closed flat. On the flip side, the NSE Industrial and the NSE Consumer Goods fell by 0.57% and 1.00% respectively. Meanwhile, market activity was weak as investors traded cautiously ahead of the release of 9M 2021 financial results. Volume and value of stock traded plummeted by 42.21% and 11.26% to 0.19 billion units and N2.59 billion respectively. In the fixed income space, NIBOR rose for most tenor buckets tracked on renewed financial system liquidity squeeze while NITTY moved in mixed directions. In the OTC bonds market, the values of FGN bonds was flattish for most maturities tracked. However, the value of FGN Eurobond increased for most maturities tracked on renewed bullish sentiment.
