

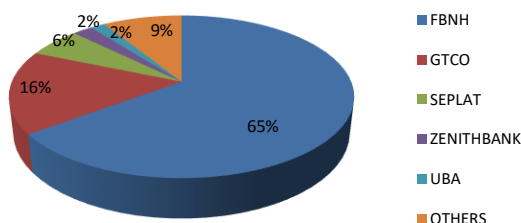
**NSE ASI Rises by 0.19% amid Sustained Bullish Trend on SEPLAT, FBNH Shares; NIBOR Falls for Most Tenor Buckets amid Sustained Liquidity Boost...**

The local bourse index rose further by 19 basis points (bps) to close at 41,129.98 points as bullish momentum was sustained today, especially on the share prices of SEPLAT, FBNH, STANBIC and WAPCO. Given the usual bullish activity in the equities market in Q4, the number of gainers (21) continues to outshine that of the losers (14). Hence, the year-to-date gain of the local bourse rocketed to 2.13%. Positive sectorial performance was skewed towards the NSE Consumer Goods and the NSE Industrial as their indices rose by 0.17% and 0.15% respectively. However, the NSE Banking, NSE Insurance and the NSE Oil/Gas indices fell by 0.86%, 1.13% and 0.01% respectively. Elsewhere, market activity came in stronger as the volume and value of stocks which exchanged hands today ballooned by 103.52% and 145.65% to 0.91 billion units and N10.97 billion respectively. Meanwhile, NIBOR fell further for most tenor buckets tracked on sustained financial system liquidity boost while NITTY moved northwards for all maturities tracked on renewed bearish momentum. In the OTC bonds market, the values of FGN bonds traded remained flat for most maturities tracked – as traders remained on the sidelines. However, the value of FGN Eurobond increased for most maturities tracked on sustained buy interest.
