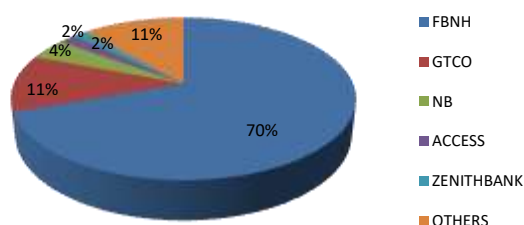
NSE ASI Rises Further by 0.75% as FBNH Shares Soar to N12.70; NIBOR Rises for all Tenor Buckets amid Renewed Liquidity Strain...

The domestic equities market index rose by 75 basis points (bps) to close at 41,438.15 points amid sustained bargain hunting activity on high-cap stocks. Notably, share prices of PRESCO, BUACEMENT, GTCO, TOTAL and FBNH topped the list of gainers today. Also, as investors shifted focus to the equities market amid lower inflation rate (16.63% y-o-y), the number of gainers increased significantly to 30, leaving that of the losers at 8. Hence, the year-to-date gain of the local bourse ballooned to 2.89%. Reflective of the positive market sentiment, the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.34%, 0.84%, 0.91%, 0.86% and 0.75% respectively. Elsewhere, market transactions mellowed today as the volume and value of stocks which exchanged hands plunged by 19.72% and 22.25% to 0.73 billion units and N8.53 billion respectively. Meanwhile, NIBOR rose for most tenor buckets tracked on renewed financial system liquidity strain while NITTY fell for all maturities tracked on renewed bullish activity. In the OTC bonds market, the values of FGN bonds traded increased for most maturities tracked – as traders took position ahead of next week bond auction. Also, the value of FGN Eurobond increased for most maturities tracked on sustained buy interest.
