

The domestic bourse sustained positive momentum as its All-Share Index rose further by 12 basis points (bps) to close at 41,814.74 points amid sustained bargain hunting activity, especially on AIRTELAFRI, TOTAL, UNILEVER, PZ and GUINNESS stocks. Hence, their respective share prices rose by 1.30%, 1.32%, 6.90%, 9.32% and 1.69%. Also, the NGX printed higher number of gainers (28) than that of the losers (20) to lift the year-to-date gain of the local bourse to 3.83%. We saw bullish performance across most sub-sectors as three of the five indexes tracked closed in green: the NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indexes increased by 1.88%, 0.43% and 0.40% respectively. However, the NSE Banking and the NSE Industrial indices moderated by 0.19% and 0.06% respectively. Elsewhere, market activity came in stronger as FBNH printed N4.35 billion worth of transactions today. Hence, the volume and value of stocks ballooned by 32.21% and 29.42% to 0.67 billion units and N7.59 billion respectively. In the fixed income space, NIBOR rose for most tenor buckets tracked on sustained financial system liquidity squeeze. Also, NITTY rose for most maturities tracked on sustained bearish activity. In the OTC bonds market, the values of FGN bonds traded moved in mixed directions. However, the value of FGN Eurobond fell for most maturities tracked.
