NSE ASI Index Moderates by 0.06% as NESTLE Shares Shed Weight; NITTY Falls for Most Maturities as Investors Await NTB Auction Result...


The domestic bourse Index melted by 0.06% to close lower at 41,789.59 points despite the Exchange printing 24 gainers as against 15 losers at the close of session. The decline in the share price of NESTLE partly accounted for the weak performance witnessed in the equities market today. The sell-offs on other high-cap stocks such FBNH, GLAXOSMITH and CUSTODIAN also contributed to a depressed stock market session today. Hence, the year-to-date gain of the local bourse fell to 3.77%. Performance across sub-sector was generally bullish, except for the NSE Consumer Goods index which closed flat. The NSE Banking, NSE Insurance, NSE Oil/Gas and the NSE Industrial indexes increased by 0.51%, 1.54%, 1.70% and 0.05% respectively. Elsewhere, market activity remained weak as the volume and value of stocks declined further by 19.43% and 42.49% to 0.28 billion units and N3.20 billion respectively. Meanwhile, NIBOR moderated for most tenor buckets tracked on sustained financial system liquidity ease. Also, NITTY fell for most maturities tracked as traders await NTB auction result. In the OTC bonds market, the values of FGN bonds traded were flattish for most maturities tracked. However, the value of FGN Eurobond increased for most maturities tracked amid sustained buy pressure.
