Local Bourse Reverses Yesterday's Gain as All-Share Index Moderates by 0.09%; NIBOR Rises for all Tenor Buckets on Renewed Financial System Liquidity Ease... The NSE All-Share Index (ASI) moderated by 0.09% to close at 41,975.45 points amid renewed profit taking activity even as the Exchange recorded higher number of losers (20) than losers (13) at the close of trading session today. We saw weak demand for ARDOVA, WAPCO, NGXGROUP, ZENITHBANK and ETERNA stocks hence their share prices plummeted by 7.53%, 2.61%, 3.00%, 2.00% and 6.16% respectively. Consequently, the year-to-date gain of the local bourse lowered to 4.23%. Negative momentum was seen across sub-sectors tracked as the NSE Banking, NSE Insurance, NSE Oil/Gas and the NSE Industrial indices plummeted by 0.11%, 0.07%, 0.16% and 0.09% respectively. However, the NSE Consumer Goods index remained unchanged. Elsewhere, market activity was relatively weak as volume of stocks traded decreased by 8.16% to 0.29 billion, while the value of stocks traded nosedived by 37.16% to N2.06 billion. Meanwhile, NIBOR and NITTY moved northwards for most tenor buckets tracked amid renewed financial system liquidity boost. In the OTC bonds market, the values of FGN bonds traded was flattish for most maturities tracked. However, the value of FGN Eurobond fell further for all maturities tracked as investors continued to demand for higher yield.




