Domestic Equities Market All-Share Index Declines by 0.08% amid Sustained Profit Taking; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

The NSE All-Share Index (ASI) plummeted by 0.08% to close at 41,943.83 points amid sustained profit taking activity even as the Exchange printed a higher number of losers (25) than losers (13) at the close of trading session today. At the top of the losing table are GUINNESS, UNILEVER, NGXGROUP, WAPCO and CUTIX stocks as their respective share prices declined by 7.27%, 8.65%, 4.38%, 1.92% and 7.50% respectively. Consequently, the year-to-date gain of the local bourse nosedived to 4.16%. Negative momentum was sustained across sub-sector gauges save the NSE Insurance which rose by 1.29% on AlICO and LINKASSURE shares. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices moderated by 0.51%, 0.58%, 0.64% and 0.13% respectively. Elsewhere, market activity sustained weak performance as volume of stocks traded further decreased by 45.08 % to 0.16 billion, while the value of stocks traded nosedived by 31.63% to N1.41 billion. Meanwhile, NIBOR and NITTY moved southwards for most tenor buckets tracked amid renewed financial system liquidity ease. In the OTC bonds market, the values of FGN bonds traded depreciated for most maturities tracked amid renewed sell pressure. However, the value of FGN Eurobond appreciated for most maturities tracked amid renewed buy pressure.
