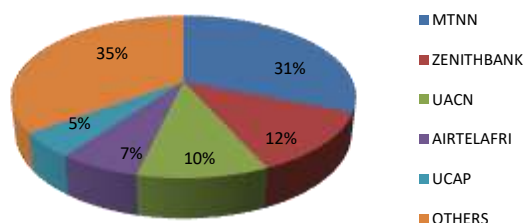
More Stocks Join MTNN, AIRTELAFRI to Lift Local Bourse Index by 1.12%; NITTY Moves in Mixed Directions ahead of Tomorrow's Auction...

The local bourse index rose further by 1.12% to close at 43,730.55 points as more stocks joined the telecoms stocks to lift the equities market today. Hence, the Exchange printed higher number of gainers (24) than losers (18). Notably, the share prices of MTNN, AIRTELAFRI, ARDOVA, WAPCO and NGXGROUP appreciated by 2.56%, 3.90%, 7.38%, 3.46% and 4.63% respectively to lift the year-to-date gain of the local bourse higher, to 8.59%. Bullish sentiment was reflected across sub-sectored gauges tracked. Specifically, the NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices increased by 0.07%, 0.21%, 0.12% and 0.21% respectively. On the flip side, the NSE Insurance moderated by 0.28%. Nevertheless, we saw market activity mellow as the deal, volume and value of stocks traded decreased by 17.03%, 36.72% and 31.14% to 4,342 deals, 280.71 million and N3.48 billion respectively. Meanwhile, NIBOR rose for most tenor buckets tracked amid renewed financial liquidity squeeze. Also, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds traded closed flat for all maturities tracked. However, the value of FGN Eurobond appreciated for all maturities tracked amid sustained buy pressure.
