
Local Bourse All-Share Index Moderated by 0.05% amid Renewed Profit Taking Activity; NITTY for 12 Months Maturity Bucket Falls as CBN Sells Bills at Lower Rate... The local bourse index fell marginally by 0.05% to close at 43,707.30 points as the bulls struggled with the bears for dominance on the Exchange today. Hence, the year-to-date gain of the local bourse mellowed to 8.53%. The marginal gap between the number of gainers (18) and those of the losers (19) was reflective of the fierce battle between the duo. Notably, dragging the All-Share Index down were the shares of WAPCO, NGXGROUP, ARDOVA, UACN and REDSTAREX as investors took profit on them amid appreciation on their share prices yesterday. The bearish trend cut across sub-sectored gauges as four out of the five indexes we track closed in red. Specifically, the NSE Banking, NSE Insurance, NSE Oil/Gas and the NSE Industrial indices declined by 0.97%, 0.34%, 0.24% and 0.25% respectively. On the flip side, the NSE Consumer Goods index rose by 0.12%. Market activity was mixed as the deal and volume of stocks traded fell by 11.08% and 3.57% to 3,861 deals and 270.70 million respectively. However, the value of stock traded rose by 61.89% to N5.63 billion as investors bought N1.47 billion worth of FLOURMILS shares. Meanwhile, NIBOR moved in mixed directions while NITTY moderated for 12 Months maturity as CBN auctioned 364-day T-bills lower at 6.50% (from 6.99%). In the OTC bonds market, the values of FGN bonds traded closed flat for all maturities tracked.
