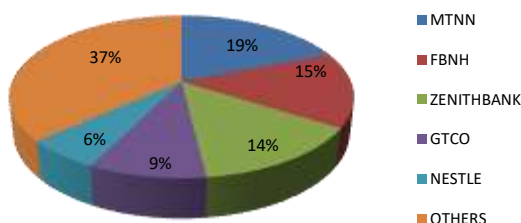
## NSE All-Share Index Falls Further by 0.36% amid Sustained Profit Taking Activity; NIBOR Falls for Most Maturities on Financial System Liquidity Ease...

The domestic stock market index plummeted by 0.36% to close at 43,549.28 points as the bears finally took over the Exchange. Hence, the year-to-date gain of the local bourse fell to 8.14%. Also, the Exchange printed a higher number of losers (19) than gainers (12). Specifically, the share prices of MTNN, CUTIX, NGXGROUP, GTCO and ETI declined by 0.50%, 8.06%, 2.16%, 0.90% and 2.31% respectively. The bearish sentiment was most seen in the NSE Banking, NSE Insurance and the NSE Industrial sub-sectors as their indices declined by 0.95%, 0.93% and 0.10% respectively. On the flip side, the NSE Consumer Goods index rose by 0.02% while the NSE Oil/Gas index closed flat. Meanwhile market activity came in lower as the deal, volume and value of stocks traded fell by 7.43%, 40.41% and 61.97% to 3,574 deals, 161.31 million and N2.14 billion respectively. Meanwhile, NIBOR fell for most tenor buckets amid financial system liquidity ease. However, NITTY rose for most maturities tracked amid renewed sell pressure at the shorter end of the curve. In the OTC bonds market, the values of FGN bonds depreciated for most maturities tracked amid renewed sell pressure. Also, the value of FGN Eurobond decreased for all maturities tracked amid renewed sell pressure.
