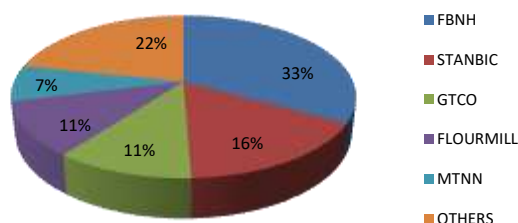
Local Bourse Index Moderates by 0.68% amid Sustained Profit Taking Activity; NIBOR Rises for all Maturities Tracked on Financial System Liquidity Squeeze...

The domestic stock market index further nosedived by 0.68% to close at 43,253.01 points as the bears sustained dominance at the close of trading week. Hence, the year-to-date gain of the local bourse moderated to 7.41%. However, the Exchange printed a lower number of gainers (16) than losers (15). Specifically, the share prices of MTNN, GLAXOSMITH, LIVESTOCK, UPDC and HONYFLOUR declined by 4.50%, 6.25%, 8.68%, 9.47% and 3.95% respectively. Most of the sectoral gauges closed positive despite the benchmark index closing lower today. The NSE Banking, NSE Insurance and the NSE Consumer Goods indices rose by 0.62%, 0.73% and 0.03% respectively. However, the NSE Industrial and the NSE Oil/ Gas closed flat. Meanwhile market activity improved as the volume and value of stocks traded increased by 95.19% and 117.28% to 314.85 million and N4.65 billion respectively as N1.54 billion Naira worth of FBNH shares exchange hands today. Meanwhile, NIBOR rose for all tenor buckets amid tight financial system liquidity. However, NITTY fell for all maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked. On the flip side, the value of FGN Eurobond decreased for all maturities tracked amid renewed sell pressure
