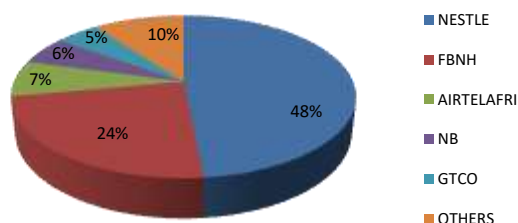
**Nigerian Stock Market Index Rebounds by 0.49% amid Gains on AIRTELAFRI, FBNH Shares; NIBOR Rises for all Maturities Tracked on Renewed Liquidity Squeeze...**

The local bourse index rebounded by 0.49% to close at 43,444.20 points amid bargain hunting on shares of AIRTELAFRI, CUTIX, FBNH, UBA and VITAFOAM. Hence, their respective share prices rose by 4.39%, 8.33%, 1.63%, 1.83% and 0.53%. Consequently, the year-to-date gain of the local bourse rose to 7.88%. The Exchange printed an equal number of gainers (18) and losers (18) as investors reshuffled their holdings. On a bearish note, we saw major sell-off on NESTLE and TOTAL shares, leading to a 0.71% and 9.97% loss in their respective share prices. Performance across sub-indices tracked was largely positive – the NSE Banking, NSE Insurance and NSE Industrial rose by 0.11%, 0.39% and 0.01% respectively. However, the NSE Consumer Goods and the NSE Oil/ Gas indices fell by 0.38% and 2.49% respectively. Meanwhile market activity was upbeat as the volume and value of stocks traded ballooned by 44.44% and 171.60% to 423.83 million and N11.65 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed financial system liquidity ease. However, NITTY moderated for most maturities tracked amid renewed buy sentiment. In the OTC bonds market, the values of FGN bonds were flattish for all maturities tracked. On the flip side, the value of FGN Eurobond decreased for all maturities tracked amid renewed sell sentiment.
